

It is proposed to fill up vacancies in the under mentioned ranks in Intelligence Bureau under the Ministry of Home Affairs on deputation basis, with willing officers of State and Central Government Units/Departments fulfilling the eligibility criteria: -

Assistant Director (Executive) Level 11 in the Pay Matrix [Pay Band-3 of Rs.15600-39100 with grade pay Rs.6600/-]	(i) Officers of the State Police Service or Central/State Police Organizations holding analogous posts on regular basis in the parent cadre/department or included in the select list for promotion to the Indian Police Service; or (ii) Officers of other All India Services/Central Service Group 'A' / Central Government /State Government / Union Territories holding analogous posts on regular basis in the parent cadre/department; or (iii) Officers of the rank of Major or equivalent in the Army or of equivalent rank from other wings of the Defence Forces.	40 [Not more than 10% of these vacancies would be filled under clause (ii) and 5% under clause (iii)]

The officers must possess the following (mandatory) qualifications:-

Desirable qualification:

- (i) Science graduate with Physics or Engineering background.
- (ii) Digital Technology Savvy.
- (iii) 7 years experience of guarding/managing physical protection of vital, critical and sensitive installations.

Note 1: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.


Note 2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Government shall ordinarily not exceed **five** years. The maximum age limit for appointment by deputation **shall not be exceeding 56 years** as on the closing date of receipt of application.

2. The application of willing and eligible suitable officers, complete in all respects, may be forwarded with the following documents so as to reach the **Joint Deputy Director/G, Intelligence Bureau, Ministry of Home Affairs, 35 S P Marg, Bapu Dham, New Delhi-110021 within 60 days** from the date of issue of this circular:-

- (i) Bio-data in the enclosed proforma (Annexure -1) in duplicate duly signed by the candidate and forwarded through proper channel; ,
- (ii) Attested copies of the updated CRs for last five years,
- (iii) Vigilance Clearance and Integrity Certificate including a statement of major/minor penalties, if any, imposed on the officers during the last 10 years (Annexure -2).

3. Application complete in all respect duly forwarded through proper channel only will be entertained. Applications received in advance or after last date or without all or any of the above documents or otherwise found incomplete will not be considered and no correspondence will be made or entertained in this regard. The officers who apply for the post will not be allowed to withdraw their candidature subsequently.

4. The officer inducted /selected to these posts will be on deputation for a period as specified in the induction order. This period can be curtailed or extended if exigencies of service so require. The deputation of the officers would be governed in terms of DoPT OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and as amended from time to time.
