All interested bidders/parties are invited to attend the auction on the date and time mentioned above. The terms and condition of the auction are as under :-

- i) The Vendors should be registered with the Government Agency as per e-waste Management and Handling Rules, 2011 published by Ministry of Environment and Forest (MOEF) Notification dated 12th May, 2011.
- ii) The bidders attending auction will have to deposit a sum of Rs. 25,000/- (Rupees Twenty five thousand) only as security money which will be refunded to unsuccessful bidders after auction is over. Only those bidders depositing security money will be allowed to take part in the auction.
- iii) Amount will be acceptable by cash. No cheque/draft will be acceptable.
- iv) The Commandant, 25th Bn. SSB, Ghitorni, New Delhi reserves the right to reject/accept the auction without assigning any reason. If any dispute arises, the decision of the Board will be the final.
- v) The stores should be sold to the highest bidder on payment of the amount in full including of sale Tax/GST on spot. In the event of failure to deposit the full payable amount by the successful bidder, the sale of lot will be cancelled and earnest money, so deposited will be forfeited.
- vi) Auction stores should be shifted on the same day and no transportation will be provided by this office for shifting of auction stores. The full amount of the accepted bid will have to be deposited at the time of fall of hammer by the successful bidder.
- vii) Inspection of U/S stores will be allowed before start the auction. The U/S stores will be disposed off on the assumption that the bidder have inspected the stores and have gone through the terms and condition of auction. No complaint of any kind will be entertained later on.
- viii) Bidder must produce photo ID, PAN card and current Income Tax & Sale Tax/GST clearance etc. to the auction Board. In absence of income Tax/Sale Tax/GST Clearance certificate security money will not be deposited and bidder shall not be allowed to participate in the auction.
- ix) The bidder should bring their PAN Card in original & photocopy at the time of bidding.
