**Terms and conditions:-**

1. The auction will be conducted by a board of Officers/Officials of the 11 Bn SSB Didihat (UK) and decision of the board will be final.
2. The bidders will have to deposit Rs. 25,000/- only as security money before start of auction and this money will be refunded to them on completion of the auction process. Only those bidders who will deposit advance security money will be allowed to take part in the auction.
3. Bidder should be registered with Govt. Agency as per E-Waste management and handling rules-2011.
4. The successful bidder will dispose off the IT items keeping in view the rule published by Ministry of Environment and Forest.
5. Security money will be collected on 5<sup>th</sup> January, 2018 from 0900 hrs to 0945 hrs.
6. In case the numbers of bidders attending the auction found below five. it may be postponed.
7. Every bidder should furnish valid income tax. sale tax. clearance certificate. In absence of income tax/sale tax, clearance certificate security money will not be deposited and bidder shall not be allowed to participate in the auction.

9. The store will be sold to bidder who has quoted the highest bid.
10. Auctioned stores should be shifted on the same day (i.e. date of auction) and no transportation or any assistance for lifting the auctioned stores will be provided by this Unit or Department.
11. Immediately, on the fall of hammer the successful bidders (highest bidder) will deposit the full amount of bidding in cash at the post. No money in the shape of cheque/draft will be entertained.
12. The Commandant 11 Bn SSB Didihat (UK)/ presiding officer reserve all rights to reject auction without assigning any reason, the decision of the board will be final and binding in all matters related to auction.
13. All taxes as applicable will be deposited by the successful bidder in the department concerned before collection of auction store.
14. The bidder should bring their PAN Card in original & photocopy at the time of Bidding.
15. Grouping/Cartel formation and advertisement during the auction process in the auction premises will not be allowed. If found any grouping on the part of any bidder, the concerned bidder/bidders will not be allowed to participate in the auction and his/their bid will be cancelled.
