**Sub:- Draft Recruitment (Amendment) Rules in respect of Sashastra Seema Bal Group 'A' Combatised Director General, Additional Director General, Inspector General, Deputy Inspector General and Commandant posts, 2019.**

DoP&T vide its OM No. AB/-14017/61/2008-Estt.(RR) dated 13.10.2015, has directed to upload proposed draft Recruitment Rules/Amendment Rules on the official web-site for 30 days for inviting comments from the stakeholders before referring the proposal to DoP&T. Accordingly, draft Recruitment (Amendment) Rule in respect of Sashastra Seema Bal Group 'A' Combatised Director General, Additional Director General, Inspector General, Deputy Inspector General and Commandant posts, 2019, have been uploaded on official website.

All stakeholders are requested to offer their comments/views, if any, within 30 days from the date of issue of this Memorandum in order to enable this office to take up the proposal with MHA/DoP&T. It may kindly be noted that no objection/suggestion will be entertained after stipulated time frame.

**G.S.R.** \_\_\_\_\_ - . In exercise of the powers conferred by clauses (a) and (c) of sub-section (2) of section 155 of the Sashastra Seema Bal Act, 2007 (53 of 2007), the Central Government hereby makes the following rules to amend the Sashastra Seema Bal Group 'A' Combatised (General Duty) Director General, Additional Director General, Inspector General, Deputy Inspector General, Commandant posts Recruitment Rules, 2013, namely:-

1. (1) These rules may be called the Sashastra Seema Bal Group 'A' Combatised Director General, Additional Director General, Inspector General, Deputy Inspector General and Commandant posts, Recruitment (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Sashastra Seema Bal Group 'A' Combatised Director General, Additional Director General, Inspector General, Deputy Inspector General and Commandant posts, Recruitment Rules, 2013,-

(A) against serial number 3 relating to the post of Inspector General,-

(I) in column (11), under the sub-heading "Promotion",-

(a) in item (a), for the words, figures and letters "Deputy Inspector General with four years regular service in Level-13A in the pay matrix (Rs.131100-216600) subject to total twenty four years Group 'A' service.", the words, figures and letters "From amongst Deputy Inspector General in Level-13A (Rs.131100-216600/-) of the pay matrix of Sashastra Seema Bal who have rendered twenty four years Group 'A' service including two years regular service as Deputy Inspector General;" shall be substituted.

(II) under column (12), for the words "Departmental Promotion consisting Committee of:", the words " Departmental Promotion Committee (for considering Promotion) consisting of:-", shall be substituted.

(B) against serial number 4 relating to the post of Deputy Inspector General,-

(I) in column (10), for the words, figures and letters "(i) Sixty percent by promotion of Departmental Officer (ii) Forty percent by deputation of the Indian Police Service Officers", the words, figures and letters "(i) Eighty percent by promotion (ii) Fifteen percent by deputation of Indian Police Service Officers (iii) Five percent by deputation of Army officers or Re-employment of Army Officers." shall be substituted;

(II) in column (11), under the sub-heading "Promotion",-

(a) in item (i), for the words, figures and letters "(i) Promotion of Commandants with-(a) four years of regular service as Commandant in Level-13 in the pay matrix (Rs.118500-214100) Subject to a total of twenty years of Group 'A' Service; and (b) two years regular service of Commandant as Commandant in duty battalion of Sashastra Seema Bal;"; the words, figures and letters "(i) Commandant in Level-13 (Rs.123100-215900/-) of the pay matrix who have rendered twenty years of Group 'A' service including two years regular service as Commandant in a field unit;" shall be substituted.

(b) item (ii) shall be omitted;

(c) item (iii) and (iv) shall be re-numbered "(ii) and (iii)"

(d) Note 1 shall be omitted;

(e) in Note-1A, for the words, figures and letters "The eligibility service shall continue to be same for persons holding the feeder posts of Commandant and Area Organiser on regular basis as on the date of publication of the Principal Rules i.e. 17<sup>th</sup> June, 2013", the words, figures and letters "The eligibility service shall continue to be same for person holding the feeder post of Commandant on regular basis as on the date of publication of the Principal Rules i.e. 17<sup>th</sup> June, 2013" shall be substituted.

(f) Note-1A shall be re-numbered "Note-1"

(g) in column (11), under the sub-heading "Deputation" for the words "By deputation of Indian Police Officers in the Central Government or the State Government holding posts of Deputy Inspector General of Police or equivalent or empanelled to hold the post of Deputy Inspector General in the Central Government" , the words "By deputation of Indian Police Officers in the Central Government or the State Government holding posts of Deputy Inspector General of Police or equivalent or empanelled to hold the post of Deputy Inspector General in the Central Government and serving Army Officers of the rank of Brigadier" shall be substituted,-

(h) in column (11), Sub-heading "Re-employment", shall be inserted, namely:-

"Re-employment: Retired Army Officers of the rank of Brigadier possessing Medical Category SHAPE-I.

Serving Army Officers of the rank of Brigadier on deputation to Sashastra Seema Bal as Deputy Inspector General on retirement from Army will be deemed to be on re-employment basis till they attain the age of superannuation."

(III) under column (12), for the words "Departmental Promotional Committee consisting of:-", the words "Departmental Promotion Committee (for considering promotion) consisting of:-", shall be substituted.

- (C) against serial number 5 relating to the post of Commandant,-
- (I) for the entries under column (4), the following entries shall be substituted, namely:-  
“Level-13 (Rs.123100-215900)”;
- (II) in column (11), for the words “Nation Level Training Institution”, the words  
“National Level Training Institutions” shall be substituted.
- (III) under column (10) and column (11), the word “absorption” shall be omitted
- (IV) under column (12), for the words "Departmental Promotional Committee consisting of:-", the words "Departmental Promotion Committee (for considering promotion) consisting of:-", shall be substituted.
