AUCTION NOTICE

It is general information to all concern that public auction will be held as per detail (the date ,time ,place and nature of mentioned below for disposal of unserviceable stores having total bock value Rs.1,222,858/- held on the charge of 44<sup>th</sup> Bn. SSB Narkatiaganj (Bihar).

All interested bidders /parties are invited to attend the auction on the date , time and venue mentioned above . The terms and condition are as under :-

TERMS AND CONDITIONS

1. The bidders are required to deposit Rs. 20,000/- (Rupees Twenty Thousand) only as security money /earnest money one hour prior to commencement of public auction and this amount will be refunded on completion of the auction. The amount will be adjusted later on against the final bid amount to the highest /successful bidder and the earnest money of the unsuccessful bidders will be returned immediately after bidding is over. Only those bidders who deposit security money will be allowed to enter into the complex and participate in the auction.
2. The stores will be auctioned on as is where basis .
3. Security money will be collected on 19/06/18 from 0900 hrs to 1000 hrs.
4. A board of officer will conduct the auction. In case of any dispute, decision of the Comdt. Authorized detail will be final and binding. No case will be entertained at any court of law.
5. Inspection of U/S store will be allowed before start of auction. The U/S store will be disposed off on the assumption that the bidders have inspected the stores and have gone through the items and condition or auction. No compliant of any kind will be entertained at later stage.
6. The unserviceable store will be auctioned lot wise.
7. The highest bid offered will be accepted or rejected by the Board of officers as per procedure /instruction.
8. On the fall of hammer, the successful bidder will deposit the entire auction price /bid amount in the presence of the Board of officers.
9. In case the purchaser fails to deposit the auctioned price/bid within the stipulated time decided by the Board, the security money will be forfeited and the bid will be considered as rejected and the stores will be put for auction again.
10. Every bidder should furnish current Income Tax and Sale Tax clearance certificate and photocopy thereof received from income Tax and Sale Tax office indicating that the bidder is assessed and permanent account number has already allotted to him at the time of signing of bid sheet. The tax clearance certificate should be in the name and address given by the successful bidder. In absence of current Income tax/Sale Tax clearance certificate no person will be allowed to participate in the auction.
11. The goods will be sold to the highest /successful bidder .The buyer will have to produce up-to-date income tax /sale tax clearance certificate from the competent authority of the Government of Bihar together with a photo copy of the same to this office for issuing clearance orders of the auctioned items from this end. The successful bidder is also required to pay sale tax as per existing norms as on the day of auction.
12. The bidder will adhere to the security instruction in the force.
13. The release order challan will be issued in the name of actual purchaser only.
14. Security / earnest money will be deposited on cash basis to the Name of Commandant 44<sup>th</sup> Bn. SSB Narkatiaganj (Bihar) instead of cheque /draft.


