Regarding holding of Special Pension Adalats on 18.09.2018 (.)

DoP&PW vide their D.O. letter dated 26.07.2018 (copy enclosed), has intimated that *Departmental Parliamentary Standing Committee* has suggested to dedicate a day to the pensioners, as part of good governance and efforts be made to minimize their grievance by holding Pension Adalats on September, 18, 2018 (.) For the above said purpose, wide and adequate publicity through print and visual media and other means like posters at prominent places may be given in advance to enable the pensioners to send their cases in time for consideration in such Adalat (.) Cases involving purely legal points e.g. SUCCESSION etc. may not be taken up in the Adalats and this aspect need to be adequately publicized (.) Moreover grievances involving policy matters need not be taken up in such Adalats (.)

For FTR Hqs. SSB, Guwahati - FTR Hqs. Guwahati will hold above said Pension Adalats for all pensioners of N.E. Region (.) Joint Secretary, DoP&PW vide their D.O. letter dated 26.07.2018 (copy enclosed) has also intimated that All India Pension Adalat at Vigyan Bhawan, New Delhi is likely to be inaugurated by Hon'ble Mos of Ministry of Personnel, Public Grievances & Pension and that the live proceedings of the Pension Adalat on 28.09.2018 from two or three locations may be connected to Vigyan Bhawan (.) Therefore, FTR Hqs. Guwahati will keep all paraphernalia ready for live video conferencing of Pension Adalat on above said date, if such directions are received from MHA by SSB (.) However, FTR Hqs. Guwahati will not make any correspondence/contact with NIC team at their own till receipt of any direction from FHQ (.)

Moreover, this office is in touch with Controller of Accounts, FAG, SSB for sparing AAOS/AOs for associating in Pension Adalats on 18.09.2018 from PAO/ZPAOs and confirmation will be sent in due course of time (.)


