

Interested Bidders/ person/Firms are invited to participate in the Public Auction to be held on 30.05.2017 at 1000 hrs at Dett. Dudhiya under 29th Bn Khaprail, in (route , Siliguri to Mirik road via Matigara, Khaprail distance approx. 30 Kms from Siliguri).

TERMS AND CONDITIONS:-

1. Bidders can take part in building after depositing Rs- 10,000 (Rupees ten thousand) only as Security money up to one hour before commencement of auction. Security money of successful bidders will be adjusted with bid amount. Only those bidders are requested to reach the value well in advance to avoid last minute risk.
2. The Security money of the bidders whose bids will be rejected shall be refunded as soon as bidding is over.
3. The auctioned stores will have to be lifted/ removed within two days of the date of auction. For the security and safety of the stores, successful bidder will have to make his own arrangement and department will have no liability for the same.
4. On the fall of the hammer the successful bidders (highest bidder) will deposited prescribed payment of the auction price/ bid with the stock holders in presence of the Presiding Officer of the Board . The stores will be sold to highest bidder on payment of bid amount in full and production of tax clearance certificate as applicable.
5. In case of failure to make balance payment of bid value by the bidder within stipulated period the sale of lot will be treated as cancelled and Security money will stand forfeited.
6. The store so auctioned will be removed completely at the bidders expense/ risk from the site and if the buyer fails to remove the auctioned stores within the stipulated period, the auctioneer will not be responsible for any loss/ damage for the same. Rent of the space occupied by the store will be charged as per rules.

7. The stores may be inspected one day before auction after obtaining approval from the Commandant 29TH Bn , SSB Khaprail (WB)
8. The stores will be auctioned on "AS IS WHERE IS BASIS" and the release order will be issued in the name of the successful bidder only.
9. The bidder should abide by the Security instructions issued by the Officers conducting auction at the value of auction.
10. Pooling and canvassing / trading during the auction/ inside auction premise will not be allowed. If any grouping/ pooling from any bidder(s) is noticed, the concerned bidder (s) will not be allowed to participate in the auction.
11. The successful bidders will be given delivery of auctioned stores after depositing sale tax with sale tax authority and showing its proof.
12. In case number of bidders fall below five, the auction shall be cancelled.
13. The Commandant 29TH Bn , SSB, Khaprail (W.B) or the Officer conducting the auction on his behalf reserve the right to accept or reject any bids without assigning any reason and in case of dispute , the decision of the Board of Officers shall be final.
