5. PIMS data of all personnel should be updated.



- ii) Sub-Inspector of Central Armed Police Forces or State Police or Union Territories with five years regular service in the grade pay of Rs.2800/- (Level-05) having experience in teaching outdoor subjects.

2) Eligibility conditions for Inspector (Training for trainers)

For deputation

- i) Officers of the Central Government or State Government or Union Territories holding analogous post on regular basis with grade pay of Rs. 4200/-(Level-6) or
- ii) Sub-Inspector of Central Armed Police Forces or State Police or Union Territories with five years regular service in the grade pay of Rs.2800/- (Level-05) having experience in teaching outdoor subjects.

3) Eligibility conditions for Assistant Sub – Inspector (Wireless)

Deputation:

From the Central Government or State Government or Union Territory-

- i) Holding analogous post on regular basis; or
- ii) Head Constable (Wireless) with three years regular service in the grade; or
- iii) Constable (Wireless) with five years regular service in the grade.

4) Eligibility conditions for Head Constable (General Duty)

Deputation:

From the Central Government or State Government or Union Territory-

- i) Holding analogous post on regular basis; or
- ii) Constable (General Duty) with five years regular service in the service

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government or State or a Union Territory shall ordinarily not exceed three years).

Pay & Allowances –

Selected candidate will have the option to draw their basic pay in the scale of pay of their parent department plus following Allowances admissible during the period of deputation.

- i) Training Allowance @ 24% on revised pay matrix as per rule.
- ii) SDA @ 10% on revised pay matrix.
- iii) Transport Allowance as per slab & other facilities like Rent free accommodation, Medical, Education, Welfare etc.

It is requested that the application with full Bio-data and service particular, course details, Confidential Report for last 5 years of the incumbent, who could be spared in the event of their selection may kindly be sent to this Academy, while forwarding the applications, it may kindly be verified and certified that the particulars furnished by the officers are correct and that no disciplinary cases are pending or contemplated against the incumbent.
