
Memorandum

Notification

G.S.R. _____.- In exercise of the powers conferred by sub-section (1) read with clauses (a) and (c) of sub-section (2) of section 155 of the Sashastra Seema Bal Act, 2007 (53 of 2007), the Central Government hereby makes the following rules to amend the Sashastra Seema Bal Combatised (General Duty) Group 'C' posts Recruitment Rules, 2011, namely: -

1. (1) These rules may be called the Sashastra Seema Bal Combatised (General Duty) Group 'C' posts Recruitment (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Sashastra Seema Bal Combatised (General Duty) Group 'C' posts Recruitment Rules, 2011,-

(I) in the Schedule,-

(A)(i) against serial number 1 relating to the post of Head Constable (General Duty), in column (12), for the words "Departmental Promotional Committee consisting of:-", the words "Departmental Promotion Committee (for considering Promotion) consisting of:-" shall be substituted;

(ii) in the entry of Heading number in the Schedule at page number 17 and 18 of English version, for the brackets and figures, "(9), (10), (11), (12), (13) (14)" the brackets and figures, "(8), (9), (10), (11), (12), (13)" shall be substituted;

(B)(i) against serial number 2 relating to the post of Constable (General Duty), in column (7), under heading "(ii) Physical and Medical Standard" the following shall be substituted:-

"Physical and Medical standards as per the scheme prescribed by the Central government for the post of Constable time to time"

(ii) in the entries under column (12), for the heading "Departmental promotional/Selection Board consisting of:-" the heading " Departmental Confirmation Committee (for considering Confirmation) and Selection Board consisting of:-" shall be substituted.
