
**Memorandum**

**Sub:- Draft Recruitment (Amendment) Rules, 2019 in respect of Sashastra Seema Bal Combatised Assistant Sub Inspector (General Duty) Group 'C' posts.**

DoP&T vide its OM No. AB/-14017/61/2008-Estt.(RR) dated 13.10.2015, has directed to upload proposed draft Recruitment Rules/Amendment Rules on the official web-site for 30 days for inviting comments from the stakeholders before referring the proposal to DoP&T. Accordingly, draft Recruitment (Amendment) Rules, 2019 in respect of Sashastra Seema Bal Combatised Assistant Sub-Inspector (General Duty) Group 'C' post have been uploaded on official website.

All stakeholders are requested to offer their comments/views, if any, within 30 days from the date of issue of this Memorandum in order to enable this office to take up the proposal with MHA/DoP&T. It may kindly be noted that no objection/suggestion will be entertained after stipulated time frame.

**Notification**

G.S.R. \_\_\_\_\_.- In exercise of the powers conferred by sub-section (1) read with clauses (a) and (c) of sub-section (2) of section 155 of the Sashastra Seema Bal Act, 2007 (53 of 2007), the Central Government hereby makes the following rules to amend the Sashastra Seema Bal Combatised Assistant Sub-Inspector (General Duty) Group 'C' posts Recruitment Rules, 2011, namely: -

1. (1) These rules may be called the Sashastra Seema Bal, Combatised Assistant Sub-Inspector (General Duty) Group 'C' post, Recruitment (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the notification Rule (8) to the post of Assistant Sub Inspector (General Duty),-

The words “**fifty seven years.**” the words “**sixty years**” shall be substituted.

3. In the Schedule to the post of Assistant Sub Inspector (General Duty),-

(A) in column (10), the words “By promotion failing which by deputation/absorption or deputation or re-employment of Armed Forces Personnel.” the words “By promotion failing which by deputation or For Ex-Servicemen: Deputation/re-employment.” shall be substituted.

(B)(i) in column (11), under “Promotion”, the following items shall be inserted, namely:-

“(a) Should have rendered two years service in a duty battalion of Sashastra Seema Bal.

**Note:-** The service rendered on deputation or posting or attachment basis in the National Level Training Institutions will be treated as 50% of the required field service for the purpose of promotion and no relaxation in respect of the remaining 50% mandatory service will be granted in such cases.”

(ii) the word “absorption” shall be omitted.

(C) in the entries under column (12), for the heading "Departmental Promotional Committee consisting of:-" the heading "Departmental Promotion Committee (for considering Promotion) consisting of:-" shall be substituted.
